
CLAUSE 1 CO-OPERATION


CLAUSE 2 SCOPE OF THE MoU



- 4.1 This Agreement will be valid until it is expressly terminated by either Party on mutually agreed terms, during which period Terox Rnd & Consultancy Services Pvt Ltd, the Second Party, as the case may be, will take effective steps for implementation of this MOU. CLAUSE 5 RELATIONSHIP BETWEEN THE PARTIES






